Responsibilities

The objective of this policy is to provide protection against sexual harassment of girl students and for the prevention and readressal of complaints of sexual harassment and for matters connected therewith. The objectives of the Committee are:

- Prevent discrimination and sexual harassment against women, by promoting gender amity among students and employees;
- Make recommendations to the Director for changes/elaborations in the Rules for students in the Prospectus and the Bye-Laws, to make them gender just and to lay downprocedures for the prohibition, resolution, settlement and prosecution of acts of discrimination and sexual harassment against women, by the students and the employees;
- ✓ Deal with cases of discrimination and sexual harassment against women, in a time bound manner, aiming at ensuring support services to the victimized and termination of the harassment;
- ✓ Recommend appropriate punitive action against the guilty party.
